## BY LAWS/RULES

- 1. All non-members on club premises are required to be signed in by a financial member of the Club. The member signing the guest in, is responsible for the guest's behaviour.
- 2. Signed in non-members are allowed entry one time only, after which they are required to apply for membership if they wish to continue coming.
- 3. Membership is capped to a maximum number and any application may be refused for any reason. Persons refused membership are not allowed on club premises for a period of one year after membership refusal.
- 4. Temporary membership is available to persons visiting Tonga at a rate of \$30.00. This is for a maximum of three months in any one year.
- 5. Only alcohol purchased from the club bar may be consumed on the club's premises.
- 6. Alcohol may not be purchased to take away or for supply to non-members outside the premises.
